## II. BACKGROUND

In early 1940s, there were only two colleges – Government Intermediate College and St. Joseph's College, in the entire city. Admissions to these colleges were difficult due to less student intake in the Government College and St. Joseph's college was beyond the reach of the common man. Sighting the hardship of the general public and the students, a group of visionaries came together and mooted the idea of starting an educational institution, to provide opportunity for deserving students to pursue Science Education. The group included Rao Bahadur Pof. B Venkateshachar, Prof. V T Srinivasan, Sri. K Lakshmi Narayana Rao and others. With the Mission of providing excellent education, BHS Managing Committee was formed in 1944 and Vijaya College was started in 1945. The Managing Committee is now named BHS Higher Education Society and several developments have occurred since the inception. At present 17 institutions are running under the banner of BHS Higher Education Society with Prof. B V Narayana Rao as the Secretary.

Vijaya College located in South of Bangalore has established itself as an educational institute of high repute. The college has been accredited by NAAC (National Assessment and Accreditation Council) with B++ grade and is due for Re-accreditation this year. The college offers Undergraduate courses in B.Sc., B.Com, BCA and BBM with student strength of about 2000. Dr. N Sathyananda is the Principal of the college

## **MEMORANDUM OF UNDERSTANDING**

**Centre For Incubation, Innovation, Research And Consultancy**, (herein after called **CIIRC**) **Jyothy Institute of Technology** (herein after called **JIT**) and **VIJAYA COLLEGE R.V. Road** (herein after called **Vijaya College**) hereby establish a formal understanding of cooperation and friendship which is intended to further the research and academic objectives of each institution and to promote better understanding between the faculty and students of **CIIRC-JIT** and the faculty and students of **Vijaya College**.. Under this Memorandum of Understanding (herein after called **MOU**), the institutions will proceed to implement the following endeavors and exchanges of materials and personnel.

### **1. Areas of Cooperation**

Assistance shall be carried out, subject to availability of funds and the approval of the competent authority of the **CIIRC-JIT** and **Vijaya College**, through such activities or programs as:

- a) Exchange of students
- b) Joint research activities and publications
- c) Participation in seminars and academic meetings
- e) Exchange of academic materials and other information
- f) Special short-term academic & professional programs
- g) Any field that the institutions are mutually interested in



## 2. Scope of Cooperation

The term of cooperation for each specific activity implemented under this MOU shall be mutually discussed and agreed upon by the parties prior to the initiation of that activity. If necessary, the parties agree to sign supplemental agreements for the development of programs or projects in specific areas.

## 3. Implementation

This MOU shall remain in force for a period of five (5) years from the date of the last signature, with the understanding that it may be terminated by the appropriate authorities of either party giving six months notice to the other parties in writing, unless an earlier termination date is mutually agreed upon.

The MOU may be amended or extended by mutual written consent of the parties.
